# Do you need a Camping Card International?

The Camping Card International (CCI) is a useful document to carry if you are camping or caravanning abroad and is essential in Denmark.

# The main benefits of the CCI are

- Covers a party up to a maximum of 11 persons
- Can be used as a form of identity and is accepted by many campsite proprietors as security in lieu of a passport. (In some countries eg Italy this will be after initially taking details from the passport, as required by law.)
- Includes up to 2,500,000 Swiss francs worth of third party insurance for accidental damage at campsites
- Many campsites offer discounts on presentation of the CCI
- In some countries there are special offers at certain tourist attractions on presentation of the CCI

# How do I get a Camping Card International?

RAC is able to issue CCIs only to RAC Members.

Please complete the application form and send it via post or fax.

You must include the fee of £8.50 with your application. Special delivery can be arranged at an additional charge of £6.95 if you require your CCI within 2 working days.

A CCI is valid for 1 year provided you have current RAC membership.

## DATA PROTECTION ACT - INFORMATION USES
